This former house and stables, of bluestone, were reconstructed in 1974 and therefore the originality of many details is questioned as the state of the buildings prior to reconstruction is unknown.

The building, as it now stands, is a pleasantly proportioned bluestone house with cast iron verandah and one of the few domestic bluestone buildings surviving in Ballarat. The large stable building at the rear of the house is notable for its size.

RECOMMENDATIONS

It is recommended that both house and stables be added to the Register of the National Estate, and be specified under Clause 8 of the Town and Country Planning Act (Third Schedule).
