RESIDENCE, 34 MERCER ROAD ARMADALE

An assessment of the cultural heritage significance of the above place has now been completed. In recognition of its cultural heritage significance, I will not be recommending that the Heritage Council include the place in the Heritage Register. Instead I will recommend that the Heritage Council refer the nomination to the relevant planning authority for inclusion of the place in its Already in flos2. (lefer Am C34 planning scheme.

The attached document outlines the basis of my recommendation including an assessment of the cultural heritage significance of the place.

Notification of my recommendation will be published in the Herald Sun newspaper on 19 July 2004. A final decision on my recommendation will not be made by the Heritage Council until after the expiration of a period of 60 days from that date.

You or any other interested parties may make written submissions to the Heritage Council before it makes its final decision. You may also request a hearing before the Registrations Committee of the Heritage Council to present your views personally or to discuss matters further. You should realise that such a hearing would be open to all interested parties. Written submissions must reach the above address before midday, 16 September 2004.

To ensure the protection of the place until the Heritage Council has made its determination, you are obliged to inform me of the following:

- Any applications for planning permits or amendments, or planning permits or amendments granted in relation to the place or object within 10 days of the action being taken or 10 days from the date of this letter.
- Any activities proposed or being carried out that may adversely affect the item within 10 days of becoming aware of them.
- Any proposals to dispose of the whole or part of the item at least 10 days before entering into a contract for that disposal.

You are also obliged to give a copy of this letter and attachments to any purchaser before entering into a contract of sale otherwise the contract may be voidable.



REASON:

The street elevation of the house at 34 Mercer Rd, Armadale has a two tiered column and beam superimposed expressed structure of a type more usually found in commercial and civic structures rather than in residential buildings. The house has, however, only one elevation of distinction and the interiors are tightly and sparely detailed. The appearance of the building is diminished by the removal of the principal entrance portico which was the only distinguishing feature to a side elevation of the house. Comparatively, the major houses Mandeville Hall [H676], Mosspennock [H420], and The Terricks, and others are superior examples of the Victorian Free Classical style. All the evidence supporting the significance of the house at 34 Mercer Rd, Armadale indicates that it is not of sufficient cultural heritage to warrant inclusion in the Victorian Heritage Register. The house is of local significance and should be retained at its present level for protection under the local planning scheme.

STATEMENT OF CULTURAL HERITAGE SIGNIFICANCE:

The construction of the residence at 34 Mercer Rd, Armadale was commenced in 1888 as a speculative venture by civil servant W J Stoddart. James Dodgshun, a warehouseman, completed then occupied the nine roomed house in 1889. Dodgshun appears to have lost the house in the 1890s financial crash as the house is in the ownership of the Metropolitan Building Society in 1894-5. Gordon Stewart, a solicitor, became owner of the house in 1896 and the family apparently retained ownership until at least 1916 when Mrs Belle Stewart is listed as the owner. During the 1930s and 1940s, 34 Mercer Rd was occupied by Sir David Rivett and his wife Stella, the daughter of Alfred Deakin. Rivett was a distinguished scientist; he was the deputy chairman and chief executive office of the Council for Scientific and Industrial Research, [the forerunner to the CSIRO], and held numerous other scientific and academic positions. In the 1950s, the house was bought by architect Karl Feller and the house still remains in ownership of the Feller family.

The house at 34 Mercer Rd, Armadale is a large two storey stuccoed brick residence with an unusual front facade with engaged columns in superimposed orders defining the arcuated four bay balustraded veranda and balcony. The original portico to the main entrance at the side of the house has been removed. An addition of a brick section to the rear of the original building was possibly constructed in about the 1920s. The principal rooms and entrance hall of the house retain their original detailing except for the probable removal of a window to the stair hall which is lit only by an added small highlight window.
