3.0 UNDERSTANDING THE PLACE

3.1 Chronology

The campus has evolved since episodically 1850 (see Figure 3). A full chronology of the site is at Appendix A.

3.2 Previous heritage studies

3.3 Physical description

The subject site is a densely developed school and religious complex with buildings and structures dating from 1850 to 2014. Generally speaking, the nineteenth century buildings are located at the west and south of the site, with twentieth and twenty-first century school buildings generally located to the east and north.

The primary address is to Nicholson Street (Figure 4, Figure 5), which has an interwar ecclesiastical presentation, with the two-storey balcony/screen to the two nineteenth century residences and 1862 chapel addition linked stylistically with the 1954-55 Walsh building to the north. At the south-east corner of the site, buildings retain their nineteenth century presentation to Nicholson and Palmer streets. The sandstone Ursula Frayne Chapel is a dominant presence on the site (Figure 6), with the Palmer Street classrooms retaining their nineteenth century presentation (Figure 7). A tall, rendered brick fence is located to the west and east boundaries, dating from c. 1926-1929.
